As informed to you vide our letter dated September 19, 2019, the Lenders of the Company have entered into an Inter-Creditor Agreement (ICA) for arriving at the debt resolution plan in accordance with the circular dated June 7, 2019 issued by the Reserve Bank of India on Prudential Framework for Resolution of Stressed Assets.

The interest payment of the Non-Convertible Debentures (NCDs) (ISIN- INE126D07123) and (ISIN- INE126D08022) due on April 5, 2022 and April 6, 2022 respectively, have not been serviced, as the Company has been directed by the lenders led by the Lead Bank not to service the said debt obligation considering the cash position of the Company.
